A deputy sifted through the personal items and determined that the property had been stolen outside our county and then dumped in three locations in our area. The debris on Deverell was scattered along a 50 yard swath of roadway. An inmate work crew arrived the following day to clean up the debris.

Deputies continue to respond to homeless related issues and complaints in the area.
